

<u>16/05/16</u> - Broadmoor Sirens All sirens at Broadmoor are being removed and replaced by warnings on Twitter and Facebook. A query was raised as to the arrangements at the other secure hospitals. Rampton has a siren on the roof of the hospital but none in the residential areas.

20/06/16 - Nothing of note

<u>15/08/16 -</u> An article in the magazine to be written to detail restrictions on times when noise with building works are not allowed, once the rules can be established

LED street lights. A resident has expressed concern about reports that some LED street lighting emits too much blue light. This can inhibit the release of melatonin, which is needed for inducing sleep. The BFC will be asked to comment.

Library There seems to be some confusion over the future of the library. It was thought that the plan for the next three years would be to run it with more automation and volunteers, but this may not be the final decision. LR to enquire. Note: Following the meeting it was established that the current status is that the review is ongoing. There will be further consultation and a final decision given in November.

 - He is concerned that
 - Due to lack of resources BFC planning aren't able to enforce the rules that are in place
 - Losing bungalows will prevent people from downsizing
 - We're losing the mix of housing in an estate. If a new development you would require a mix
 - People aren't adhering to existing pallet.
 - The biggest Issue is virtual demolishment and replacement of bungalows
- Website
 - The Association is incurring additional costs as the website builder used to create the website has gone into extended support. New action added for the website to be migrated.

- Gas works
 - Gas works were to start 29/08/16
 - Sarah Campbell @BFC can stop people working if they don't comply
 - Notices went up with 29/08 but they weren't intending to start until 05/09
 - Contractors were emailed to replace notices and warned if they didn't they would not start
 - They now have to re-apply for a new contract.
 - The gas pipes will be replaced by a new plastic liner in the metal pipes.
 - They must have lights based on location which need to be manually operated to accommodate traffic.
